# Terms & Conditions (AGB) for participants (including speakers, exhibitors and companions)

#### 1. Applicable law & legal venue (Gerichtsstand)

- 2.1. Credit card payments can be cancelled within 10 days. Afterwards all payments are final and not refundable.
- 2.2. **Equal** substitutes are possible if announced **immediately** and no later than **two weeks** before the event.
